Instructions for Parent Manager Election 2009-2010

1. All candidates are required to attend “**The Third AGM and PTA Standing Committee Members Election of HKUGA College**” on **15th May, 2010**. Each candidate shall introduce himself/herself within 2 minutes in the Election.
2. All parent members (1 Ballot Paper per family) of HKUGAC are entitled to poll only **one** Parent Manager.
3. The candidate who obtains the greatest number of votes will be nominated for registration as the Parent Manager whereas the one who obtains the next greatest number of votes will be nominated for registration as the Alternate Parent Manager. In the event of two or more candidates receiving the same number of greatest votes, the result shall be decided by drawing lots by the Election Supervisor. If there is only one candidate running for the election, he/she will automatically be elected as the Parent Manager.
4. The Nomination Period closes on **20th April 2010**.
5. All candidates must :
 - i. complete a “Self Nomination Form”; and
 - ii. submit the originally completed and signed “Self Nomination Form” together with 1 personal or family photograph (optional), through the General Office to the Election Supervisor, Mr. Sydney Wong, **before 5:00p.m. on 20th April 2010**.
